Sculptor Halima tells of delight at MBE award

A NIMBLE-fingered sculptor from South Shropshire has spoken of her pride at being awarded an MBE in the New Year Honours

Pakistan-born Halima Cassell received the commendation for her established style and outstanding contribution to the arts, fusing her Asian roots with a fascination for African pattern work.

The 45-year-old from Aston on Clun, near The 45-year-old from Aston on Ciun, near Craven Arms, works primarily in bronze and clay to create a range of geometric sculptors that can be seen at exhibitions, displays and galleries across the globe. With an ongoing project that moves to include clay and designs

from all parts of the world, Halima's work featured in a major exhibition at Manchester Art Gallery from 2019.

Her sculptures also feature at many public collections including the Victoria & Albert Museum and can be seen in Blackburn, the Forest of Bowland, the Ribble Valley, Nottingham, Hepworth Wakefield Gallery, Birmingham and Liverpool. "I've been carving clay for about 25 years and it's such an honour to receive this recognition," Halima said. "I feel so proud. I live in a little village and as I moved here I'm hoping this will help integrate my family and I into the community and show that we are contributing.

"I was born in Kashmir but I've lived most of my life in the north west of England. While building my career, Shropshire has become my home. It's where my kids and friends are and living here has been a very important stage of my career."

The MBE comes as Halima prepares to re-ase a book of her work called Halima Cassell, 25 Years of Carving.

"I'm quite eager to find out who put me for-ward for this and how it's come about," Halima

4 Police leading g crackdown on modern slavery

POLICE officers in Dyfed-Powys are urging people to look out for signs that someone could be a victim of slavery after launching a campaign INTACT.

The campaign, which is being led by the Serious and Organised Crime Team, will focus on a different area of crime each month, starting with modern day slavery. Temporary Detective Sergeant Rob Claypole at Dyfed-Powys Police explained that officers work on active intelligence about potential slavery victims as part of engoing operations and investigations in the force area.

Potential victims are then spoken to away from their place of work or accommodation – and crucially, away from potential

away. From their piace on work or accounting dation—and crucially, away from potential exploiters.

You need to take potential victims away from the exploiters in order to gain their confidence and trust," said DS Claypole.

He said modern slavety was a global problem and an international crime, affective millions of people worldwide, including problem and an international crime, affect-ing millions of people worldwide, including the UK. "Men, women and children of all ages and backgrounds can fall victim to labour exploitation, being forced to work for little or no pay," he added.
Often in rural locations, labour exploitation can see people working for the exploiter but also living at the site.

The risk to the victim is that if they give up the work, they lose their accommodation.

"We also look out for vulnerability and coercion, which is where the exploiter would find a victim who is vulnerable in some way – for example through being homeless or having an addiction," said Mr Clavrole.

"It can be very difficult for a victim to leave these sorts of situations as they fear they would lose the thing they need be that somewhere to live, access to drugs, or their earnings."

As part of INTACT, officers are encouraging people to look out for signs that someone could be a victim of labour exploitation.

+Coroner calls for changes after death

A CORONER has called for improvements to a fence at a Shropshire psychiatric clinic after a patient left the site and later died from a drug overdose.

Lee Davies, 36, scaled the fence at the Laurel ward at the Redwoods Centre, in Somerby Drive, Bicton Heath, Shrewsbury, on June 17, 2019. The next day he was found at an address in Church Stretton and taken to Royal Worcester Hospital. He died later that day.

Following the inquest in October 2020 the jury returned a narrative verdict that he died from a brain injury caused by the successful drugs. The hearing was told his risk of absconding to obtain drugs was not adequately considered when deciding to reduce his observation levels on the morning of June 17. Shropshire Assistant Coroner Mrs Joanne Lees has now written to the entre's operators Midlands Partnership NHS Foundation Trust under a Regulation 28 Report to Prevent Future Deaths over his care. In response, the trust executive said efforts were in hand to make changes to the fencing.

However, it stated that it was "satisfied that the garden is maintained in such a way that it is therapeutic to service users and balances the risk of being able to conceal objects as any objects hidden by service users would have to be brought through the ward first". It added: "This review found that the presence of the foliage immedes service user's access to the fence impedes service user's access to the fence thus reducing the ability to scale it."

A HOUSE in a village in Shropshire has been damaged in a fire.

Emergency services say that thankfully no-one was hurt in the blaze which broke out in the semi-detached home. The alarm was raised at 4.20am. Crews were mobilised from Bishop's Castle, Clun, Minsterley, Shrewsbury and Telford Central.

Lord Clive's East India Company traded slaves and his wealth was spent on Powis Castle.
